SAGA Student Membership renewable up to a maximum period of two years. Actors who are attached to verified community-based theatre groups are also eligible for Student Membership, which is renewable subject to appropriate motivation. In addition to preferential access to training opportunities and certain discounts, SAGA Student Members enjoy the support of the Guild and its Executive Committee in all work related matters. Legal queries can be addressed by our Executive Committee, however all formal legal action offered as part of the Guild's legal services offering is reserved for Full SAGA Members only. Any legal action by Student Members would be for their own account. Membership is renewable annually, effective 1 March to 28 February the following year. You hereby declare and confirm that you, as the SAGA member providing information, do hereby irrevocably agree and understand that any/all information supplied or given to SAGA, is done so in terms of the Protection of Personal Information Act 4 of 2013 (POPI Act) including any amendments. SAGA may collect, hold, use and disclose your personal information while you are registered as a member for the purposes of administration and organisational requirements. The information we hold may include but is not limited to; your legal and professional name, email address, a home, postal or other physical address, other contact information, cv, photograph(s), your title, birth date, gender, race, contracts, and banking details. Your information will be accessed by SAGA on password and anti-virus protected computers, stored in the cloud or on password protected servers managed by a third-party service provider, which may be located outside of South Africa. Where SAGA shares your information, we will take all precautions to ensure that the third p arty will be POPI complaint and will treat your information with the same level of protection and confidentiality required by the POPI Act. Should you no longer be a member, your information will be kept for no longer than 10 years upon which the SAGA information officer will delete your personal information. Particular information such as name and phone number may be kept for longer for record keeping purposes.
